**Please sign and return the contract before the due date of April 25, 2019. Once the contract has been received by CanGift an invoice for the first payment will be immediately issued. Failure to send in signed Contract for Exhibit Space and the initial deposit by April 25, 2019 could result in the loss of booth space.**
